Joshna reaches Hong Kong final

HONG KONG: India's leading squash player Joshna Chinappa carved out a close win against defending champion Annie Au to enter the final of the PSA HKFC International here on Friday. Joshna, the lone Indian left in the draw after the exit of teammate Dipika Pallikal, won the crucial points against the higher-ranked opponent from Hong Kong in the semifinal lasting an hour. The eventual scoreline read 8-11, 11-9, 12-10, 7-11, 11-9 in favour of the Indian. Joshna had also got the better of Annie in the recently held Asian Team Championship in Taipei. Joshna, seeded third, faces top seed Joelle King of New Zealand in the final on Saturday. "Every point was fought to the max, just happy to get through to my biggest ever PSA final," said the World No13 after reaching the summit clash of the \$25,000 event.

Sonia settles for silver

ASTANA (KAZAKHSTAN): Indian boxer Sonia Lather (57kg) settled for a silver medal at the 'AIBA Women's World Championships after going down to top seed Alessia Mesiano of Italy in a hard-fought summit clash here on Friday. The lone Indian boxer to make the medal rounds, Sonia lost 1-2 but her silver ensured that India did not return emptyhanded after what was a throughly disappointing campaign overall. The 24-yearold from Haryana was off the blocks confidently and managed to rattle Mesiano in the opening round with her precisely-placed combination punches. However, the Italian, who was a bronze-medallist in the previous edition, kept her composure and counterattacked well in the next three rounds.

Streak quits Bangladesh

DHAKA: Former Zimbabwe captain Heath Streak said he will quit as Bangladesh's fast bowling coach at the end of the month after deciding not to renew his contract. The Bangladesh Cricket Board (BCB) said Streak. who has been linked with a coaching post at India's national academy, informed them of his decision via email. "I have decided that I shall leave my role as a national bowling coach when my contract expires at the end the month." Streak said in a statement via his agent on Twitter on Thursday. The Zimbabwean coach, who signed a two-year contract in 2014, has been credited with the steady progress made by Bangladesh's fast bowling unit, which contributed to the team's successful run in ODI's. "I feel now is the right time for me and my family to make this decision and I look. forward to the future as I look to continue my coaching career," he said in the statement.

Dhirendra breaks record in Pole Vault KOZHIKODE: Dhirendra Kumar of Gujarat shattered the national and meet records to bag the gold in the boys Pole Vault category on the second day of 13th National Youth (Under 18) Athletics championship here on Friday, Kumar vaulted a height of 4.72m to claim the first place in boys Pole Vault, bettering the national record of 4.70m set by P Kumar Patel of Uttar Pradesh in 2010 and the meet record of 4.41 m by Kundan of Haryana in 2011. Delhi's Manish Singh came second with 4.40m followed by

Krishnan of Haryana who finished third with 4.30m. In the boys long jump, Kerala's M Sreeshankar covered a distance of 7.49m breaking a meet record of 7.41m set by Madhya Pradesh's Ankit Kumar in 2009.

23 new doping failures from 2012 Oly

LAUSANNE: The International Olympic Committee today reported 23 new doping failures from retests on 265 samples from the 2012 London Games. The 23 were from six countries and took part in five different sports. The revelation came one week after the IOC said 31 new cases had been found from 2008 Olympics. "Reanalysis of the "A" samples from 23 athletes in five sports and from six National Olympic Committees who competed at the London 2012 has returned Adverse Analytical Findings," IOC said in a statement.

NZ schedule for 2017-18 confirmed

WELLINGTON: New Zealand Cricket has announced a domestic schedule for the next two summers which includes 12 Test matches and a total of 98 days of international cricket. The schedule for the 2016-2017 season includes seven Tests - two each against Pakistan and Bangladesh and three against South Africa along with 11 ODIs and four T20s. New Zealand will also play a three-match Chappell-Hadlee one-day series against Australia with matches in Auckland, Napier and Hamilton. South Africa's tour comprises three Tests, five ODIs and a Twenty20 match. The 2017-2018 domestic season, which will contain five Tests, 17 ODIs and five T20s, will be one of New Zealand's busiest on record.

Court, which in a judgment on Friday held that any private broadcaster sup-plying live feed of sports events to Prasar Bharati must supply "clean feed" free of all commercials and logos of sponsors.

The judgment came as a setback to Star Sports India Private Limited, which is mandated under the Sports Broadcasting Signals (Mandatory Sharing with Prasar Bharati) Act, 2007 to share live feed of sport events without advertisements. Prasar Bharati had objected to Star Sports on April 6, 2013 not to show on-screen credits of its sponsors which amounted to commercial advertisements, that violated Section 3 of the Act.

But Star maintained that the onscreen credits which appear alongside the graphs and statistics of the match and players displayed throughout the match is part of the "world feed" it received from the content provider International Cricket Council and it is this content that is beamed by it to all service providers including direct to home, cable operators and Prasar Bharati. This argument failed to convince the Delhi High Court that dismissed Star's plea and ordered clean feed to be supplied to the public broadcaster as mandated by the Act.

Dismissing Star's appeal, the apex bench of Justices AK Sikri and Prafulla C Pant said, "Radio as well as television broadcasting of Prasar Bharati is free of cost. It is for this reason that the law in the form of Sports Act is enacted in order to ensure that such sporting events of national importance are made available to every citizen of this country, irrespective of his/her financial conditions." Moreover, the Court held that of feed is provided minus advertisements it will enable Prasar Bharati to enter into arrangement with advertisers and charge accordingly as its reach is the widest in the country.
